Intelligent Multi Door Controller:

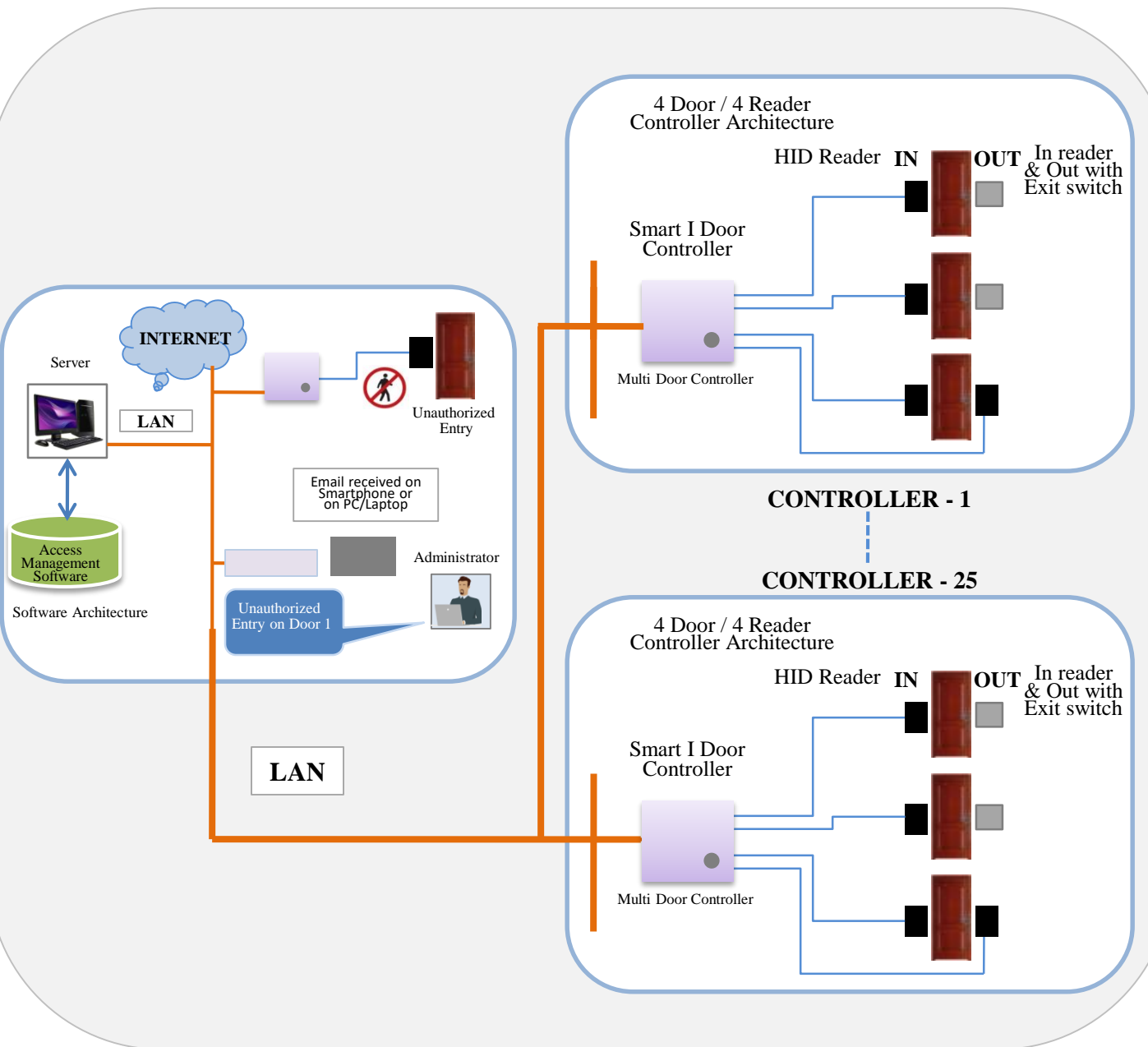
Smart I has deployed multi-door IP based smartXS (4 Door/4 Reader) controller with HID card reader. All controllers are connected through Access Management Software on LAN. Software will be used for report generation and security configuration setting. There is no master slave concept limitation; so all security/authorization decisions are taken by controller itself. The systems has many access restricted features for restrict entry of unauthorized person ie; Access Level, Time Zone, Anti pass back, etc.

Access Management Software

Smart I's Access Management Software (smartENGINE) which is connected with all controllers on LAN. The software is used mainly for downloading the transactions, generating different types of reports and configuring various security settings, controller wise/door wise/reader wise. A premise with 100 doors like Renesas where security parameters and level of security are varied from door to door, smartENGINE has facility where user can manage the security level as per requirement by configuring various features door wise.

Smart I has deployed the complete integrated solutions commissioned by **Sobha Projects and Trade Pvt. Ltd.**, Bangalore. The solution is equipped with sophisticated Smart I's multi door Controllers, HID reader, EML Lock and Access Management Software.
